



Schengen Short Stay Visa Requirements

Visa for Fishermen / Seamen

General rules:

- The application form and all documents (original + copy) are to be submitted in person.
- Applications will be refused by the Embassy if accompanied by forged documents and will be also reported to other EU Embassies in Egypt.
- The visa fee will not be refunded in case of refusal or withdrawal

How to apply:

Prior to submission of a visa application, an appointment has to be fixed with our external service provider (VFS Global) at one of their centres in Cairo and Alexandria. This can only be done online through the VFS website: <https://visa.vfsglobal.com/egy/en/mlt>

Visa requirements:

Visa Application Form	<ul style="list-style-type: none">• Must be filled in English only.• Must be submitted in person together with the supporting documents
Original Passport	<ul style="list-style-type: none">• Issued within the last ten years• Contains at least two blank pages• Passport valid for at least 3 months after return from the planned trip.
One biometric photo	<ul style="list-style-type: none">• White background• Not older than six months.
Travel Insurance	<ul style="list-style-type: none">• This must cover the whole duration of stay• For Egyptians, the Aman Travel Insurance sticker must be affixed on the Egyptian passport

Original bank account statement	<ul style="list-style-type: none"> • With an official bank stamp and signature • Showing activity over the last 6 months. • The bank statement should be dated maximum 15 days before the date of submission. - In case the bank statement does not show sufficient funds to cover the applicant's travel, accommodation and living expenses while in transit in Malta, a guarantee from the employer is required stating that they will cover these expenses.
"Kid Aely" (Family Register)	<ul style="list-style-type: none"> • In the case of married applicants, "Kid Aely" (Family Register) is required. • In the case of non-married applicants, "Kid Fardy" (Individual Register) is required. • In the case of minors, "Kid Aely" (Family Register) of the father is required, clearly indicating the name of the said minor on the document.
Letter of invitation	<ul style="list-style-type: none"> • On company letterhead, stamped and signed, stating: <ul style="list-style-type: none"> - The job of the applicant - Fishing vessel name and number - Contact details of the inviting person - In case the applicant is unable to provide a bank statement showing sufficient funds to cover his/her travel, accommodation and living expenses while transitting in Malta, a guarantee from the employer is required stating that they will cover these expenses.

Fishermen ID	<ul style="list-style-type: none"> • Valid for at least 3 months from the end of the validity of the visa
National ID	<ul style="list-style-type: none"> • Copy from the valid national ID and to be translated in English.
In case of fishermen	<ul style="list-style-type: none"> • Police conduct certificate
In case of seamen	<ul style="list-style-type: none"> • Seamen passport, valid at least 3 months from the end of the validity of the visa • Yellow medical card
<i>For first time travellers to Schengen Area / In case of lost passport</i>	<ul style="list-style-type: none"> • "Mogamma" / Movement Certificate • Only applicable to 18 years and older
