4	<p>Proof of residence or legal stay in China if applicable A residence card, which validity shall extend at least 3 months after the intended date of departure from the Schengen territory, or a document confirming legal stay in China.</p> <p>在中国居住或合法居留证明如适用 居留证，其有效期应在预定离开申根之日起至少长于 3 个月，或证明在中国合法居留的文件。</p>
5	<p>The number of mediation letter _____, submitted electronically by the inviting company through the Information System of Public Services https://epis.vrm.lt/epis. 6	<p>Proof of financial means (original and copy) A document certifying that an applicant has sufficient funds (e.g. a statement from a bank account) and/or receives regular income (e.g. an employment contract) for: - subsistence in Lithuania (sufficient means of subsistence is 1 minimum monthly salary - 555 EUR for one month); - return to the country of origin or foreign country to which he/ she is entitled to travel (sufficient amount of return funds is 1 minimum monthly salary - 555 EUR)</p> <p>财务证明（原件和复印件）：</p>

The applicant has to provide copies of all documents which cannot remain with the Embassy (e.g. passport, residence card, bank book, etc.)

Supporting documents that are not in English or Lithuanian must be accompanied by a translation.

Embassy of Lithuania in China may request additional supporting documents at any time.
