



# Croatia Checklist for Transit Visa

1.	<b>Application form filled online on <a href="https://crovisa.mvep.hr/default.aspx">https://crovisa.mvep.hr/default.aspx</a></b> duly completed (in Croatian or English) <b>all the required documents to be uploaded</b> while filling the application. Application must be signed by the applicant in person (or by parents(s) guardians) for minors under the age of 18), signatures are in point 37 & below the declaration.	
2.	<b>The Passport</b> must be valid a least three months after the date when the holder leaves Croatia, containing at least two empty pages and issued within the previous 10 years. Copy of 1 <sup>st</sup> page of the applicant's passport, <u>Copies</u> of Schengen, UK, USA. Australia, Canada. New Zealand, Japan Visas in the last 5 years.	
3.	<b>Two identical recent Passport photograph</b> meeting Croatian requirements (glued on the application form).	
4.	<b>Health insurance</b> with the policy coverage valid for the entire stay and accepted in Croatia. The insurance must cover the minimum amount Of EUR 30'000.	
5.	<b>Transport flight booking</b> or airline ticket including return trip (e.g. ticket reservation only copy), if not available (via car), information about destination and itinerary.	
6.	<b>Letter from the employer</b> showing evidence of income and position. 3-month salary slips to be submitted along with the letter from Employer. for students (under 18 years): student card (copy) and sponsorship letter from parent.	
7.	<b>Proof of entry into a third country</b> (visa issued for a third country, if required) or proof of itinerary (travel ticket, etc.).	
8.	<b>For Third Country Nationals:</b>	
9.	<b>Copy of residence Permit</b> (ID Card) of Oman (both sides), to be valid for at least 3 months beyond the departure from Croatia or a document is to be submitted that the holder has applied for the renewal of legal residence.	
	If applicable. Copy of the work permit or registration card.	
10.	<b>For children under 18 years:</b>	
10-1	<b>Copy of Child birth certificate translated in English</b> and Parent's passport Copy.	
10-2	If a child travels alone or is accompanied by one of his /her parents an authorization letter translated (into Croatian or English) and signed by both parents.	
10-3	Parent's Croatian visa or other legal entry permit (E.g. Valid Multiple Schengen visa) Copy to be submitted if travelling together with the child or If the parent submits his/her application not at the same time. Application form for Croatian Visa completed and duly signed by both parents. If the child is travelling during the schooling year then letter from the school with his details and permission of his/ her leave.	
	<b>Remarks</b> _____  <b>Declaration:</b> I have been informed that an application without a complete set of documentation according to above mentioned checklist may result to the rejection of my visa application. The Embassy of Croatia reserves the right to ask for an additional supporting document and does not guarantee the issue of visa.
