3	Passport /travel document must: a) have a validity of at least 3 months after the intended stay b) be issued within the previous 10 years c) have 2 blank pages It is recommended to attach old Schengen, UK, USA or Canada visas as well as any other previous visas. You should to provide copy of all pages of your valid passport with stamps on it.		
4	Two way (flight, train or bus) ticket reservation (in accordance with insurance and accommodation).		
5	Overseas travel medical insurance valid for all Schengen countries. The insurance has to cover the applicant for at least 30,000 euros or equivalent, for all risks e.g. accident, illness, medical emergency, etc.		
6	Certificate of the sending and the receiving institutions duly signed and stamped by an authorized person.		
7	Provide evidence of suitable English or Bulgarian language ability to be able to benefit from the education in case of students.		
8	Reservation(s) of accommodation for the whole period of stay (in case of multiple city all reservations are needed).		
9	Employer's certificate needs to contain the following: job title, address, start date of employment, monthly amount of income and salary slip of the last three months. Formal requirements: letterhead paper, stamp, and corporate signature.		
10	Detailed bank account statement of the past three months.		
11	For minors a declaration by the legal representative on the coverage of the costs certified by notary public. If travelling alone or with one parent (legal representative), minors are requested to present a declaration from the legal representatives / other legal representative.
