2	One recent passport size photograph in light-colored background, size 3,5 x 4,5 cm		
3	Passport /travel document must: a) have a validity of at least 3 months after the intended stay b) be issued within the previous 10 years c) have 2 blank pages It is recommended to attach old Bulgarian, Schengen, UK, USA or Canada visas as well as any other previous visas. You should to provide copy of all pages of your valid passport with stamps on it.		
4	Two way (flight, train or bus) ticket reservation (in accordance with insurance and accommodation).		
5	Overseas travel medical insurance valid for all Schengen countries. The insurance has to cover the applicant for at least 30,000 euros or equivalent, for all risks e.g. accident, illness, medical emergency, etc.		
6	Original Invitation declaration; The invitation has to be certified by a notary and the Migration Directorate of the Ministry of Interior in Bulgaria; Copy of ID card (both sides) of inviting person		
7	Employer's certificate needs to contain the following: job title, address, start date of employment, monthly amount of income and salary slip of the last three months. Formal requirements: letterhead In case of self-employment, certificate of registration. / For students, certificate from school (from the latest semester). / For pensioners, Pension slip of the last three months.		
8	Detailed bank account statement of the past six months.		
9	For minors a declaration by the legal representative on the coverage of the costs certified by notary public. If travelling alone or with one parent (legal representative), minors are requested to present a declaration from the legal representatives / notary		
10	Title deed (if you own property).
