Please note that your application is incomplete if any of the document(s) marked below are missing. The Embassy therefore kindly requests that you hand in the below documentation.

	<b>Cover letter</b> completely filled on <a href="https://applyvisa.um.dk/">https://applyvisa.um.dk/</a> , printed and signed by the applicant.
	<b>Visa Fee payment receipt</b> printed from <a href="https://applyvisa.um.dk/">https://applyvisa.um.dk/</a>
	The <b>Original passport</b> should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of <b>previous visas and stamps</b> of the applicant's old passport(s) <i>if any</i> .
	Copy of <b>name or surname change certificate</b> , if applicable.
	<b>For non-Cambodian Citizen only: Proof of legal residence in Cambodia</b> , valid for at least 3 months beyond the intended date of departure from the Schengen territory
	<b>Proof of occupation.</b> Original documents confirming employment, private business (business/commercial registration), school or studies and permission for leave.
	An <b>itinerary</b> of the planned trip if several countries are visited -if travelling in an organised trip: a certificate or voucher (original) from a travel agency or tour operator confirming the booking of an organised tour
	<b>Confirmation of accommodation</b> in Denmark (and other Schengen countries, if the applicant is going to other countries on the same trip)
	<b>Documentation of funds to cover the trip.</b> Bank statement for the last 6 months. <i>According to the Danish Immigration Service you must have the <b>necessary means</b> to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day if you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. You can find further information <a href="https://www.nyidanmark.dk/">https://www.nyidanmark.dk/</a></i>
	<b>Round trip ticket.</b> <i>Flight/train/ferry reservation with fixed travel dates of maximum 90 days to Denmark and other Schengen countries. (Do not buy the ticket until a visa has been granted).</i>
	Overseas <b>travel medical insurance</b> valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.
	<b><u>If the applicant is under 18, he/she must also submit:</u></b> <b>Copy of birth certificate*</b> (bring <u>original</u> for verification)  <i>If you are travelling alone:</i> <input type="checkbox"/> An original letter of consent signed by both parents together with copies of the parents' ID-documents, containing signatures. <i>If you are travelling with only one of your parents:</i> <input type="checkbox"/> An original letter of consent from the other parent together with a copy of parent's ID-document, containing a signature. <i>If the parent you are travelling with has single custody:</i> <input type="checkbox"/> A copy of certificate of single custody* (bring <u>original</u> for verification).

**Note:** Official documents marked with \* must be legalized by the competent local authority. Legalization must be maximum 3 months old. A translation to English by an authorised translator must be attached to any documents in Khmer.
