1	<b>Application form – <u>available online free of charge</u></b> One application form duly completed and signed by applicant.		
2	<b>Original Passport and Passport Copy</b> Note: The passport and the Oman resident permit must be valid at least 3 months longer than the intended date of return from Hungary. The passport must contain the signature or the fingerprint of the holder. At least <b>2 consecutive blank pages</b> must be available in passport. Passport issued more than 10 years ago will not be accepted. <b>Photocopy of relevant passport pages: data page, previous Schengen, UK and USA visas</b>		
3	<b>One recent passport photograph</b> Note: (not older than 6 months); for men: without head cover. For photo specification please refer to our website		
4	<b>Letter from local sponsor</b> Stating designation, salary and start date of employment in the Oman or Legally translated trade license CR copy if self-sponsored. <b>Or</b> Bank statement for the last three months, in original or photocopy with original bank stamp.		
5	<b>Copy of invitation letter from the host company in Hungary</b>		
6	<b>Letter confirming which party will cover travel expenses</b> and/or up-to-date personal bank account statement for the last 6 months ( <b>original and stamped from the bank</b> ) if travel expenses will be covered by applicant.		
7	<b>Hotel booking</b> - full address of the host/the hotel must be written in the application: full name, street name, no. of building, city and city code.		
8	<b>Overseas Medical Insurance copy</b> - covering the territory of the Member States of the Schengen Agreement and with minimum coverage of EUR 30, 000 for medical expenses, repatriation and evacuation.		
9	<b>Flight ticket or flight reservation including return flight</b> and 1 photocopy thereof.		

**Please note:**

- Applicants must appear in person.
- All documentation must be submitted in English or Hungarian language.
- Only original documents will be accepted; additional photocopies may be required.
