



Croatia - Checklist For Tourist Visa

	One application completed and signed by the applicant. For children application should signed by parents
	One recent passport photograph not older than 6 months with white background
	Valid Passport for at least 3 months after returns from Croatia and contain at least two empty pages back to back and issued within the previous 10 years.
	<ul style="list-style-type: none"> • Copy of the first page of applicant’s passport showing personal data and copies of Schengen, UK, USA, Australia, Canada, New Zealand, Japan Visas for the past 3 years • Residence permit and CPR copy (3 Months Validity after return date)
	<ul style="list-style-type: none"> • All applicants have to submit a hotel or apartment booking confirmation (for private apartment booking) solution for performing the activity of renting).Hotel or apartment booking needs to contain (date of intended stay, booking ref No, hotel address, and contact phone number. in case the bookings provided in the application is modified/cancelled the visa may be refused. • Letter of Guarantee for the inviting person (certified). • Flight reservation including return trip
	<p>For children under 18 years of age : In addition</p> <ul style="list-style-type: none"> • Copy of passport and valid Croatian visa of the parents travelling together with the child, if the parents submit his /her application not at the same time. • If a child travel alone or is not accompanied by at least one of his /her parents: an authorization letter translated into English and signed by the parents. • Child birth certificate (copy).
	<ul style="list-style-type: none"> • Financial means For visa-applicants , • Bank statement: Applicant’s Original bank account dating back at least 3 months and showing sufficient assets. • Confirmation of employment Letter of employment indicating: <ul style="list-style-type: none"> - Status of employment and amount of monthly salary - Assurance that the applicant is still working for the company after the holiday or business-trip as well as the travel-date • Sponsors signature approval of the Bahrain Chamber of Commerce or Ministry of Social Affairs (art. 18) • For pensioners: Pension certificate. • For students: proof of enrolment in school/university
	All Risk Health and Travel Insurance with minimum coverage of EURO 30.000,--per person valid for the entire stay and accepted in Croatian space.
	Additional documents and copies might be requested in some cases.

Please note:

- The visa must be applied for in person
- All documentation must be submitted in English language
- For children registered in a parent’s passport, a separate application form has to be submitted.
- Original documents must be presented along with photocopies.
