<ul style="list-style-type: none"> <li>• <b>Two recent passport size photographs</b> (Not older than 3 months, size: 3,5 - 4,5 cm, white background and neutral expression necessary, no head or face covering acceptable except for religious reasons; please do not staple).</li> </ul>		
<ul style="list-style-type: none"> <li>• <b>Original passport with Bahrain residence permit and the Bahraini ID card</b>, all valid for at least three months longer than the intended stay. The passport must have been issued within the last 10 years, must be in a good shape and have at least 2 empty pages. The applicant needs to provide a photocopy of the identity page of the passport, the Bahrain residence permit and any previous Schengen visas from the last 3 years.</li> </ul>		
<ul style="list-style-type: none"> <li>• <b>Positive Decision of the Office of Citizenship and Migration Affairs of Latvia (OCMA/PMLP) granting residence permit in Latvia.</b></li> </ul>		
<ul style="list-style-type: none"> <li>• <b>Flight ticket reservation.</b></li> </ul>		
<ul style="list-style-type: none"> <li>• <b>Travel insurance certificate valid for 90 days. The minimum coverage of 42,600 EUR</b> including the costs of urgent medical attention and/or emergency hospital treatment in case of an illness as well as repatriation in the event of death. Medical insurance policy can be obtained in applicant’s country of residence, or in any other country, or taken out by the inviting person. It is important that the insurance meets all the above requirements.</li> </ul>		
<ul style="list-style-type: none"> <li>• <b>Visa fee – 90 EUR + VFS Global fees</b></li> </ul>
