Argus Sensor Barriers offer access solutions that combine functionality with aesthetic flexibility.

The Sensor Barrier Argus 80 is a high-security full cast layer. It has a particularly solid and refined look, as the upper section, with the front and rear vertical frame sections, is worked seamlessly in one piece. The shimmering metal has the look of an 'endless' hand rail. The accessories vary in terms of security modules, colour combinations, running light, ambient lighting and door heights.

The basic equipment includes two door wings made out of polycarbonate and four glass side panels. Additionally, the running light and standard card reader fixing is incorporated.

Reference service life

The reference service life of the Argus 80 is about 20 years, depending on the application and frequency of use. For repairs and renewals, suitable spare parts are available. The Argus 80 is tested and certified to EN 16005, meaning they are designed to withstand a minimum of 1.000.000 cycles.
