

Product

Product description/Product definition

PureView Plus is a movable glass partition system that combines modern aesthetics with space flexibility and daylighting. It features a convertible pass door for flexible egress, acoustical control up to 37 STC, and secure foot-operated interconnecting floor bolts. Available in multiple configurations including Single, Paired, Continuously Hinged panels. PureView Plus offers various glass and finish options, including anodized aluminum and over 170 RAL powder coat colors. Designed for durability and ease of use, it supports safe, reliable operation in everyday use.

For the use and application of the product the respective national provisions at the place of use apply:

- *Sound Transmission Class (STC)*
- *Americans with Disabilities Act (ADA)*

Application

PureView Plus movable glass partition systems are intended for interior applications including commercial office environments, education, healthcare, hospitality, and multi-purpose spaces and provide the primary function of partitioning interior spaces.

Manufacture

The manufacturing process primarily consists of short line and long line assembly operations. Key stages include frame layout, frame assembly, trimming, inspection, and final packaging. The specific manufacturing steps and processes may vary depending on the product type and configuration.

Reference service life

The reference service life of PureView Plus is about 25 years, depending on the application and frequency of use (approx. 50 closing cycles per year). For repairs and renewals, suitable spare parts are available.
