

Product

Product description/Product definition

The Acousti-Seal Premier system is a movable wall solution designed to accommodate a wide range of architectural and functional requirements with an STC rating of 50. The system supports multiple finish, layout, and egress configurations, allowing integration with various interior construction conditions. Its design flexibility enables both distinct visual applications and alignment with existing building elements.

For the use and application of the product the respective national provisions at the place of use apply:

- *Sound Transmission Class (STC)*
- *Americans with Disabilities Act (ADA)*

Application

Modernfold Acousti-Seal Movable Wall Systems are intended for interior applications including commercial office environments, education, healthcare, hospitality, and multi-purpose spaces and provide the primary function of partitioning interior spaces.

Manufacture

The manufacturing process primarily consists of short-line and long-line assembly operations. Key stages include frame layout, frame assembly, trimming, inspection, and final packaging. The specific manufacturing steps and processes may vary depending on the product type and configuration.

Reference service life

The reference service life of Acousti-Seal Premier is about 20 years, depending on the application and frequency of use (approx. 50 closing cycles per year). For repairs and renewals, suitable spare parts are available.
