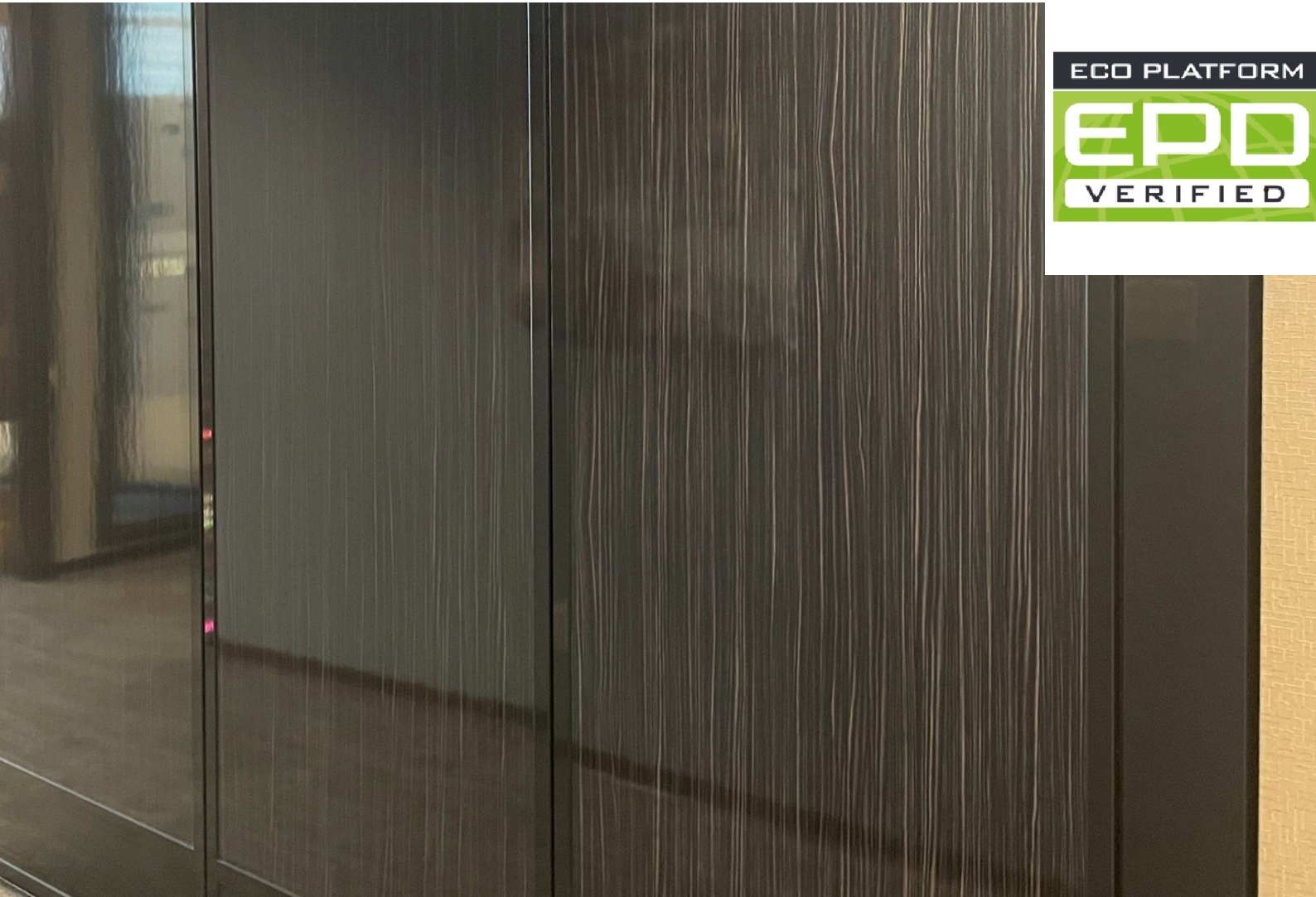



The Acousti-Clear Demountable Solid Partition Wall System is a fixed panel wall solution designed for flexible interior configurations. The solid panel configuration offers STC rating of 50. Solid panels support a range of finish options, including wood veneers and plastic laminates. Panels are constructed with aluminum frames, which may be powder coated in any of over 180 RAL Classic colors (optional).

Manufacture

The manufacturing process primarily consists of short-line and long-line assembly operations. Key stages include frame layup, frame assembly, trimming, inspection, and final packaging. The specific manufacturing steps and processes may vary depending on the product type and configuration.

Reference service life

The reference service life of the Acousti-Clear Demountable is about 30 years, depending on the application and frequency of use (approx. 50 closing cycles per year). For repairs and renewals, suitable spare parts are available.
