Canadian Natural Resources Limited "Canadian Natural" is in the process of scheduling the abandonment and reclamation of the above mentioned well site and access road. The reclamation activity will continue until a reclamation certificate is issued. As Canadian Natural has a large inventory of wells to abandon and reclaim, it is likely that these operations will occur during the farming season.

The subsurface abandonment work will be performed to Alberta Energy Regulator (AER) standards and the surface reclamation component will conform to standards outlined by the Environmental Protection and Enhancement Act as governed by Alberta Energy Regulator (AER). Further information on the abandonment and reclamation process follows:

- A service rig will abandon the well and all surface facilities will be removed from the site, if not already done.
- Following abandonment, a qualified representative of CNRL will assess the site and develop a reclamation program based on the findings. If you wish, these programs will be discussed with you and we invite your comments. The program for this site will be scheduled into CNRL's overall reclamation program.
- When the reclamation work or period of monitoring is complete our representative will do a site assessment to evaluate soil depths and composition, vegetative growth and landscape characteristics (i.e. drainage). In order to complete this work off-lease soil samples referred to as control points will have to be taken. If these samples are going to be taken during the crop season we will be contacting you to make arrangements. If the crop is not present we will proceed with this work.
- After the reclamation work is complete we may propose an amendment to the Surface Lease to reflect the removal of the adverse effect. The amending agreement provides compensation for possible losses you may incur until the reclamation certificate is issued.
- When our representative determines that the site meets the government's wellsite reclamation criteria, we will apply to the AER for a reclamation certificate. A copy of the application for the reclamation certificate will be forwarded to you at that time.
- Upon receipt of a reclamation certificate we will surrender the lease, withdraw and discharge the caveat from the title and all future compensation, payable under the terms of the surface lease, will cease. A letter advising you of our surrender of the lease will be sent to you.

Further, you may have the right to appeal the issuance of the reclamation certificate to the AER. Also, we may have the right to appeal if the reclamation inspector refuses to issue the reclamation certificate.
