

**OFFER OF PURCHASE AND SALE FOR THE EN BLOC**

BY AND BETWEEN:

**BERNIE FESCHUK & JEREMY DEAN GRABAS**

(the "**Vendor**")

AND

(the "**Purchaser**")

1. The Vendor agrees to sell to the Purchaser and the Purchaser agrees to purchase from the Vendor the property legally described in the attached Schedule "A" (the "**Property**").
2. The Purchaser hereby offers to purchase the Property for the sum of the Closing Bid (for Parcels 1 through 5) on the CLHbid.com auction taking place on July 26, 2023 plus the final 'en bloc' premium bid totaling \$\_\_\_\_\_ and calculated as set out on Schedule "B" (the "**Purchase Price**"). The Purchase Price will be payable as follows:
  - \$ \_\_\_\_\_ 20% Deposit paid to the Vendor's Lawyer further described in Section 3.
  - \$ \_\_\_\_\_ 80% balance payable, subject to adjustments and Transaction Fee, payable on or before the Closing Date to the Vendor's Lawyer
  - \$ \_\_\_\_\_ **PURCHASE PRICE**
  - \$ \_\_\_\_\_ Transaction Fee payable at 1.25% + GST on the Purchase Price and in addition to the Purchase Price will be paid with closing funds on the Closing Date by the Purchaser and their lawyer to the Vendor's Lawyer
3. The Purchaser agrees to submit on or before 4:30 pm on July 27, 2023 an executed copy of this Offer along with a Bank Draft or Electronic Bank Deposit in the sum of 20% of the Purchase Price made payable to Carter, Lock & Horrigan (the "**Deposit**"). The Deposit, upon payment, shall be unconditional.

4. The Purchase Price does not include Goods and Services Tax ("**GST**"). The Purchase Price will be subject, on the Closing Date, to the addition of GST which shall be paid by the Purchaser to the Vendor on the entire Purchase Price. Alternatively, in the event the Purchaser represents and warrants to the Vendor that the Purchaser is a registrant under the *Excise Tax Act* (Canada) and provides the Vendor with their GST registration number prior to the Closing Date together with a GST indemnity then the Purchaser may account directly to Canada Revenue Agency for the GST payable on this transaction without paying same to the Vendor.
5. The Purchase Price shall be paid in full on or before August 25, 2023 (the "**Closing Date**").
6. The Purchase Price includes 24 hopper bins, epoxy coated fertilizer bins, several calving shelters, corrals with water bowls and fuels tanks (located on SW-28-52-10-W4).
7. Possession of SW-28-52-10-W4 will be made available following the Purchaser paying closing funds on the Closing Date to the Vendor's Lawyer. Possession of the balance of the land will be made available following the existing tenant removing the 2023 crop, cattle and bales until the end of the 2023 season. Should the existing tenant be unable to complete harvest and removal of crop in 2023 due to weather, they shall have the right to harvest and removal of the 2023 crop until May 12, 2024. (the "**Possession Date**").
8. The Purchaser shall have access to NE-22-52-10-W4 & SE-27-52-10-W4 subject to the Purchaser paying closing funds on the Closing Date to the Vendor's Lawyer, for the sake of hunting, provided that they maintain respect for any crops and/ or livestock remaining on the Property.
9. All money owing to the Vendor shall be paid to the Vendor's Lawyer on or before 12:00 noon on the Closing Date. Any monies received after 12:01 pm shall be deemed to have been received on the next business day. If the Vendor agrees to accept monies after the Closing Date, the Purchaser shall pay interest at a rate of 7% per annum on any money owing to the Vendor as at the Closing Date, from the Closing Date until that money has been paid.
10. The Vendor's Lawyer will deliver normal closing documents to the Purchaser's Lawyer upon reasonable conditions consistent with the terms of this Offer.
11. The Purchaser hereby acknowledges that if registration of the transfer documents, and Purchaser financing, if any, cannot be registered by the Closing Date due to Alberta Land Titles registration timeline delays then the Purchaser shall obtain a title insurance policy to avoid delays past Closing Date at their expense.
12. All normal adjustments for the Property including but not limited to surface leases, taxes, municipal utility charges, and interest shall be adjusted as at noon on the Closing Date. The Purchaser acknowledges that the land rental payments regarding the crop will be excluded from the said adjustments.
13. The Purchaser agrees to pay a transaction fee equal to 1.25% of the Purchase Price plus GST (the "**Transaction Fee**") in addition to the Purchase Price. The Transaction Fee will appear on the Statement of Adjustments as provided to the Purchaser's Lawyer.

14. The Property shall be free and clear of any financial encumbrances attributable to the Vendor. The Property may be subject to all non-financial encumbrances now on title such as easements, utility right of ways and covenants and conditions registered against the Property.
15. The Purchaser has inspected the Property and agrees that the Vendor has not made any representation, warranty, collateral agreement or condition regarding the Property or any adjacent land or lands in close proximity to the Property or otherwise which may in any way directly or indirectly affect the Property or regarding this Offer other than what is written herein.
16. The Vendor represents and warrants to the Purchaser that:
  - (a) They are not now (nor will be within 60 days after the Possession Date) a non-resident of Canada within the meaning of the *Income Tax Act* (Canada);
  - (b) They are not agents or trustees of anyone with an interest in the property who is (or will be 60 days after the Possession Date) a non-resident of Canada within the meaning of the *Income Tax Act* (Canada); and
  - (c) They have the legal right to sell the Property.
17. The parties hereto agree that the representations, warranties, and covenants herein shall not merge by the acceptance of documents, registration of documents, or the taking of possession by the Purchaser.
18. Upon this Offer being accepted by the Vendor, this document shall, as of the date of such acceptance, constitute an agreement of sale and purchase, notwithstanding the fact that formal documents may be required and the Purchaser and Vendor both agree to promptly execute and deliver all necessary documents and do all necessary acts in order to fully carry out and perform the true intent and object of these presents.
19. This Offer shall be open for acceptance up to but not after 4:30 pm on July 28, 2023 and may be accepted by PDF email to the Purchaser.
20. Time shall be of the essence in this Offer.
21. In this Offer, the masculine gender and the singular shall be construed as the feminine gender and the plural where the context so requires. This Offer shall enure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.

22. The Agreement may be executed in several counterparts bearing PDF, electronic, or facsimile signatures, each of which so executed shall be deemed to be an original, and such counterpart together shall constitute one and the same instrument.
