

SCHEDULE A

of conditions attached to and forming part

of Order No. E142/83

1. The Operator shall conserve the top soil in a good and workmanlike manner, having regard to good soil conservation practices and any reasonable request or direction of the owner in connection therewith.
2. The Operator shall exercise reasonable precaution and take whatever measures are necessary to contain its operations to the area granted by the Order, including the travel and movement of vehicles and other equipment.
3. The Operator shall not knowingly obstruct or impede the natural drainage of the remainder of the land, and to that end shall install or construct such culverts and other works as the owner may reasonably require.
4. The Operator shall construct and maintain such fences and other works and to such standard as the owner or any person claiming by, through or under him may reasonably require to ensure the safety and prevent the straying of livestock.
5. Except as may be authorized by any other Act, the Operator shall not drill any well on the area granted for the purpose of obtaining water for domestic use, except by prior consent of the owner.
6. The Operator shall prevent noxious weeds from growing on the area granted, in compliance with the Noxious Weeds Act as to the prevention and destruction of same.
7. The Operator, and its agents, contractors and employees, and any other person or persons, shall not engage in the wanton discharge of firearms on or adjoining the area granted by the Order, nor shall any domestic animals in the keeping of such agents, contractors, employees or other persons be allowed to roam at large in the area.

ORDER GRANTING RIGHT OF ENTRY

UPON THE APPLICATION of PanCanadian Petroleum Limited, dated
December 6, 1982, pursuant to the Surface Rights Act (hereinafter referred
to as "the Act"), for an order for right of entry in respect of the surface
of the land herein described for its operations for or incidental to the
drilling for and production of petroleum and natural gas;

AND WHEREAS the area applied for is reasonable for the Operator's
operations;

AND WHEREAS the Operator has filed with the Board:

- (a) Certified copy of the certificate of title to the land applied for,
- (b) Copy of Well Licence No. 96076, dated May 31, 1982, issued by the
Energy Resources Conservation Board, and
- (c) Affidavit of Proof of Service of the said Application and of Notice in
Form B in the schedule to the Act upon the Respondent;

AND WHEREAS seven clear days have elapsed from the date of personal
service of the said Application and Notice upon the Respondent and no
objection has been received from him by the Board;

IT IS ORDERED that:

1. The Operator be and is hereby granted right of entry in respect of the
surface of the land shown outlined in red on the plan attached hereto
for the removal of minerals and for or incidental to any drilling
operations and for the construction and operation of tanks, stations
and structures for or incidental to such drilling operations or the
production of minerals;
2. The owner and any person claiming by, through or under him shall have
the right to use the area shown outlined in red on the said plan
 - (a) if necessary to gain access to the parts of
his land severed or otherwise affected thereby, and
 - (b) for livestock at large,

and for those purposes the Operator shall provide such crossings and other works as may reasonably be required,


subject to the Operator's right to use the said area for its operations and to fence its tanks, stations and structures thereon; and
