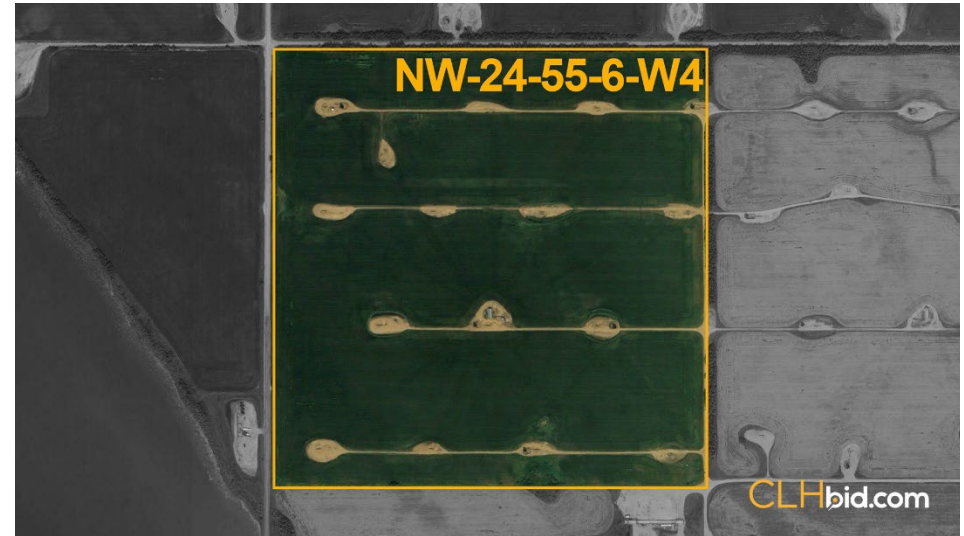

No dirt work will be done without talking to the landowner first.”
