

INDEPENDENT REPRESENTATIVE (IR) AGREEMENT

INDEPENDENT REPRESENTATIVE COMMISSION SCHEDULE Appendix A

- Commissions are calculated and paid monthly on Commission Bearing Premium received from the policyholder and recorded as paid by Edge Benefits Inc. through EFT. The unearned portion of any commission paid to you under a policy that has terminated will be charged back to you as indebtedness to Edge Benefits Inc.
- Commission Bearing Premium (CBP) is the monthly premium collected, minus any applicable policy fees and taxes.
- Commissions are payable monthly by the 15th of each month on premium recorded as paid by Edge Benefits Inc. Premium must be recorded as paid by Edge Benefits by the EDGE month-end of the prior month to be considered for commission payment.
- Commissions can be paid under one of two options: Levelized or Heaped. Once a commission option is selected it can only be changed once each calendar year.

Should the IR place business through an MGA Distributor, the IR is not eligible for a direct Bonus. Any Bonus payable should be agreed upon between the MGA IR and the MGA distributor.

Available incentives are communicated in a timely fashion in advance of the incentive period. This commission schedule above is effective on the date of your IR agreement and supersedes all previous commission schedules. It is subject to change; please keep any updated commission schedule with your contract.
