#### IMF's benchmarks and soft commitments

# A draft law on establishing High Public Disputes Court was submitted to the Parliament.

New court will replace the liquidated Kyiv District Administrative Court for hearing administrative cases against national state agencies (e.g., NBU, NABU, NACP). According to the relevant draft law #12206, judges of the HPDC will be selected by a commission of 6 persons, three of which should be nominated by international partners and will have a decisive vote. The draft law should be adopted by end-December 2024.

#### 2025 State Budget to be adopted this week.

On Monday, Nov 18, the Budget Committee recommended for the 2nd reading the draft law #12000, which pertains to the 2025 State Budget. On Nov 21, the Parliament is set to vote on this draft law. According to MPs in the working group, the President is expected to sign the draft law on tax increases this week. As a result, the budget will include expenditures based on these anticipated revenues.

# The Committee on Infrastructure considers a draft law on railway market.

The draft law #12142, submitted by the CMU, is aimed to open the railway market for private participation, allow privately operated cargo trains and enhance governance of

## the railway sector. Currently the draft law is waiting for the approval from the Parliamentary Infrastructure Committee.
