Umgomo wesikhathi eside wesikhwama somhlalaphansi ukuqikelela ukongiwa kwemali yomhlalaphansi, kodwa lezi zinguquko zikahulumeni zivumela amalungu ukuba akwazi ukufinyelela ingxenywe yemali yawo yomhlalaphansi kuphela lapho kuvela izindleko ezingalindelekile nalapho enezinkinga zezimali.

- Yonke imali etshaliwe njengamanje kanye nokukhula kwemali etshaliwe esikhathini esizayo kuzoqhubeka nemithetho yamanje.
- Uma kwenzeka ushiya emsebenzini, ungakhetha ukuhlala esikhwameni, udlulisele imali kwesinye isikhwama somhlalaphansi esigunyaziwe, noma unikezwe imali yakho esandleni.

U-10% wenani elitshalwe ngomhla ka-1 Septemba 2024 lizodluliselwa engxenyeni yokonga. Leli nani lizovalwa ku-R30 000 futhi lifakwe engxenyeni yokonga.

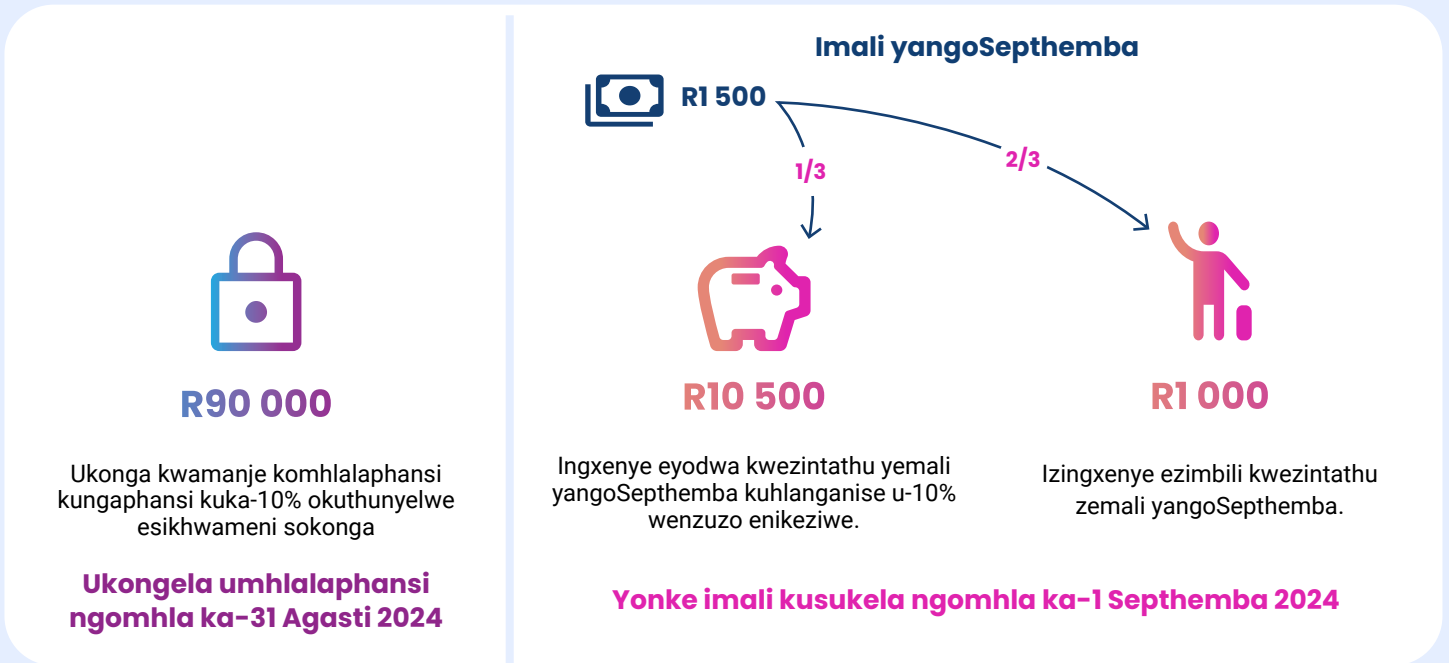
Izingxenywe ezimbili kwezintathu zemali yesikhathi esizayo

- Sebenzisa ingxenywe yomhlalaphansi ukuze uthenge impesheni.
- Ngeke ukwazi ukukhipha lezi zimali lapho ushiya emsebenzini noma uma uthatha umhlalaphansi ngaphandle uma inani lemali yomhlalaphansi liwela ngaphansi kwesilinganiso esingu-R165 000

Isibonelo sohlelo lwezikhwama ezimbili zomhlalaphansi zelungu elisesikhwameni se-umbrella noma se-retirement annuity:

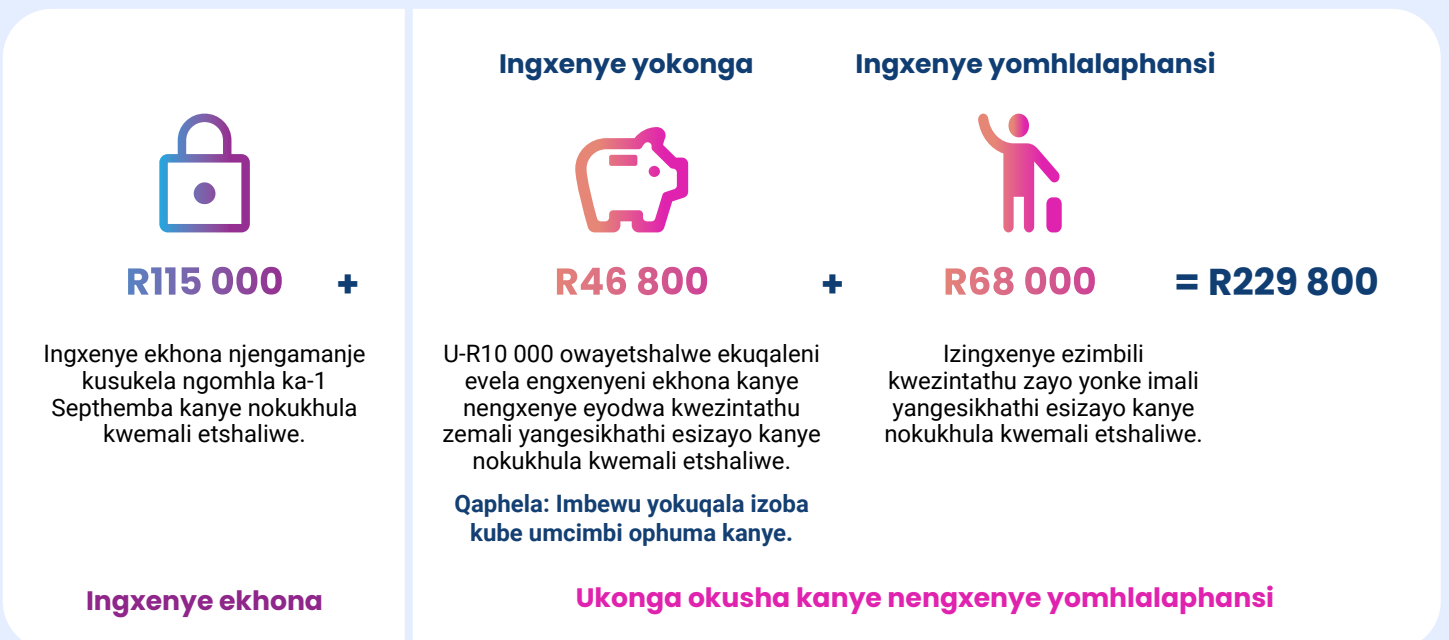
Njengamanje uThandiswa uno-R100 000 otshalwe esikhwameni somhlalaphansi ngomhla ka-1 Septhemba 2024. Imali yakhe ayifaka nyanga zonke ngu-R1 500. U-R10 000 uzothunyelwa ngomhla ka-1 Septhemba 2024 esikhwameni sakhe sokonga ukuze akwazi ukufinyelela ngokushesha. Imali ayifaka nyanga zonke izohlenganisa u-R500 otshalwa engxenyeni yokonga kanye no-R1 000 otshalwa engxenyeni yomhlalaphansi.
