

# 10X Preservation Fund Pricing Promotion

Terms & Conditions

April 2026



Apply during the promotional period (16 March 2026 – 31 May 2026) and lock in a product fee of 0.49% per year on your 10X Preservation Fund. Combined with fund trading costs, your total annual investment cost is less than 0.70%. This pricing is locked in for as long as you remain invested in your 10X Preservation Fund, subject to the terms and conditions below.

## FSP

The FSP is 10X Investments (Pty) Ltd, an authorised FSP #28250 ("the promoter").

## Who can participate?

- This promotion is open to all South African residents who are in possession of a valid identity document, and foreign nationals who can present their passport.
- Any participant under the age of 18 years must be fully assisted by his/her legal guardian, who approves of, and consents to, the participant's possession/receipt of the promotional offering.
- Employees at 10X Investments, partner agencies/affiliated companies and members of their immediate family are allowed to participate in this promotion.

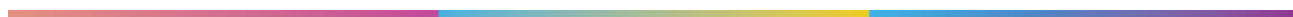

- Members of the 10X Umbrella Funds who apply to transfer their benefits to a new 10X retail Preservation Fund product during the promotional period.

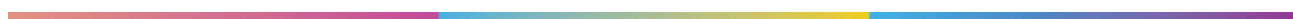
## Promotion period

## How does the promotion work?

- Participants must submit a completed and signed application with all supporting documents for a 10X Preservation Fund product during the promotion period.
- Participants must submit their application via the online application portal: <https://www.10x.co.za/invest-portal> or complete and submit a manual application form before the end of the promotional period.
- Eligible participants will be charged a fixed product fee of 0.49% per year on their 10X Preservation Fund. This product fee applies regardless of which underlying fund the participant selects. In addition to the product fee, fund trading costs apply. Fund trading costs are incurred within the fund itself and are reflected in the fund's daily unit price, not charged separately to the participant's account. Historical fund trading costs have ranged from 0.10% to 0.20% per year. The total annual investment cost – product fee plus fund trading costs – is less than 0.70%. There are no additional administration fees, platform fees, or hidden charges. The product fee is calculated daily and deducted monthly in arrears from the participant's investment.
- The promotional pricing replaces the standard Preservation Fund fee schedule (which is based on investment value tiers) with a single flat product fee of 0.49% per year, regardless of the fund selected or the value of the investment.
- Promotional pricing will be applied from the date of the participant's initial investment in the Preservation Fund product.
- The product fee of 0.49% per year is intended to remain fixed for as long as the participant remains invested in the relevant 10X Preservation Fund product. This product fee will not revert to the standard Preservation Fund fee schedule after the promotional period ends. Fund trading costs may vary over time as they depend on market conditions and fund activity.
