

## The Febreze Auto “Free Gas” Sweepstakes

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **Timing:** The Febreze Auto “Free Gas” Sweepstakes (the “**Sweepstakes**”) begins at 12:00:00 a.m. Eastern Time (“**ET**”) on May 1, 2025 and ends at 11:59:59 p.m. ET on June 30, 2025 (the “**Sweepstakes Period**”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.
2. **Eligibility:** The Sweepstakes is open only to legal residents of Canada who have reached the age of majority in their province or territory of residence as of the last day of the month prior to date of entry. Employees of Procter & Gamble Inc. (the “**Sponsor**”), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, including Don Jagoda Associates, Inc. (“**Administrator**”) and their immediate family members (spouses, parents, children, and siblings and their spouses) and/or household members of each (whether related or not), are not eligible to participate or win. Void outside Canada and where prohibited by law. All provincial, territorial, municipal and local laws and regulations apply.
3. **How to Enter:** There is **NO PURCHASE NECESSARY** to participate in the Sweepstakes. A purchase does not increase your chances of winning.
  - a.) Enter Via P&G Good Everyday: During the Sweepstakes Period, you may enter the Sweepstakes by visiting <https://www.pggoodeveryday.ca/signup/febreze-auto-free-gas> (“**Website**”). You will first be prompted to either log in or create a P&G Good Everyday Canada account. There is no cost to register for P&G Good Everyday. Terms and conditions of P&G Good Everyday apply. After either signing in or signing up for P&G Good Everyday you will be asked to fill out the registration form to receive one (1) entry into the random drawing. Once registration form is completed, confirm compliance with the official rules and click “Submit” to submit your entry. Limit one (1) entry per person/email address via the Website method of entry.
  - b.) Enter by Email: You may earn a Sweepstakes entry without signing up for P&G Good Everyday by sending an email to FebrezeAuto@dja.com during the Sweepstakes Period. The email must include your first and last name, mailing address and month and year of birth to receive one (1) entry into the Sweepstakes. You will earn one Sweepstakes entry for each email sent.

All entries must be received by 11:59:59 p.m. ET on June 30, 2025 in order to be eligible. Any attempt by any entrant to enter by using multiple/different email addresses, mailing addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified. Use of any automated or computer system to participate online is prohibited and will result in disqualification. Normal Internet/phone access and data/usage charges imposed by your online/phone service may apply.

4. **Privacy:** Information collected from participants is subject to Sponsor’s Privacy Policy at [https://www.pg.com/privacy/english/privacy\\_statement.shtml](https://www.pg.com/privacy/english/privacy_statement.shtml) and will be used and disclosed for the purpose of administering this Sweepstakes. This section does not limit any other consent(s) that an entrant may provide the Sponsor in relation to the collection, use and/or disclosure of their personal information. Entrants’ information will be transferred to the US.
5. **Random Drawing:** Two (2) winners will be selected in a random drawing on or about July 7, 2025, on or about 9:00 a.m. ET, from among all eligible entries received within the Sweepstakes Period. The drawing will be conducted by Don Jagoda Associates, Inc. (at their offices in Melville, NY USA), an independent judging organization whose decisions are final on all matters relating to the Sweepstakes. Odds of winning are dependent upon the total number of eligible entries received during the Sweepstakes Period.

6. **Winner Notification/Prize Redemption:** Potential winners will be notified by email on or about the drawing date listed above. To be declared a winner, selected entrants must first complete a written Declaration and Release Form ("**Release**") confirming compliance with the Official Rules and correctly answer, unaided a time-limited skill testing question to be administered by email. Selected entrants will be required to sign and return via email to the address stated on the Release within three (3) business days of notification. Failure to reach a potential winner within three (3) business days of notification, return of notification as undeliverable, or if a potential winner otherwise does not meet all Sweepstakes conditions, will result in all rights to the prize to be forfeited and an alternate winner may be selected. No correspondence pertaining to this Sweepstakes will be entered into except with potential winners.
7. **Prizes (2):** Gas for a year awarded in the form of a CAD \$4,300 Sponsor specified prepaid card. Prepaid card terms and conditions apply. CAD \$4,300 is based on an average of 52L per week for 52 weeks at \$1.577/L which is the cost in the month of February 2025. The prize must be accepted as awarded. No transfer, substitution, refund or cash equivalent for a prize will be permitted, except at the sole discretion of the Sponsor and in such circumstance, an alternate prize of equal value (as determined solely by Sponsor) will be awarded and the Sponsor's obligation to the winner will be fulfilled, and no other additional compensation will be provided.
8. **General rules:** By participating in the Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and/or Administrator which are final. Entries become the property of the Sponsor and none will be acknowledged or returned. The Sponsor accepts no liability for printing errors on material(s) distributed for this Sweepstakes nor will any responsibility be taken for lost or late entries or for technical, hardware, software or telephone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the user or by any of the equipment or programming associated with or utilized in the Website or the Sweepstakes or by any human error which may occur in the processing of the entries in the Sweepstakes or for any liability for damage to any computer system resulting from participation in, accessing or downloading information in connection with the Website or Sweepstakes. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. Winners may be required to show proof of being the authorized account holder of the email address provided at time of entry. Proof of entering information via the Website or email does not constitute proof of delivery or receipt of such information. Sponsor is not responsible for the failure of any entry to be received by Sponsor on account of technical problems or congestion on the internet or at any website. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or Website; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. **Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes or Website may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.** Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right to modify the Sweepstakes or disqualify entrant if fraud, misconduct or technical failures destroy the integrity to the Sweepstakes as determined by the Sponsor, in its sole discretion.
9. **Release:** Without limiting any other provisions of these Official Rules, by accepting a prize, winner agrees to release and hold harmless the Sponsor, Administrator, its agencies, suppliers, and each party's respective subsidiaries,

affiliated companies, officers, directors, employees and agents, from and against any and all claims or cause of action including but not limited to any injury, loss, cost or damages of any kind to persons, including death and property, damages sustained due in whole or in part, directly or indirectly, from entry creation, the acceptance, possession, use or misuse of a prize or parts thereof, if applicable or participation in the Sweepstakes or participation in any Sweepstakes or related activity. By entering the Sweepstakes, you hereby represent and warrant that you have read these Official Rules and are fully familiar with its contents.

- 10. Publicity:** By accepting a prize, winner agrees to be governed by these rules, and, if requested, agree to have his/her name and address (city and province only) in a winner list. Winner further agrees to allow the Sponsor to use his/her name, address (city and province only) and photograph in perpetuity without compensation for advertising or other purposes worldwide, in any and all media now known or hereafter devised, including the Internet, without compensation related to this Sweepstakes.
- 11. Governing Law:** All issues concerning this Sweepstakes shall be dealt with in accordance with the laws of the province of Ontario. You agree that: (a) any and all disputes, claims and causes of action arising out of, or connected with the Sweepstakes or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the province of Ontario; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event lawyer's fees; and (c) notwithstanding the foregoing, you waive the right to claim any damages, whatsoever, including, but not limited to, punitive, consequential, direct or indirect damages.
