

TAMPAX X TEMPO TICKET GIVEAWAY
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES.
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **Timing:** Tampax x Tempo Ticket Giveaway (the “Sweepstakes”) begins 12:00:00 a.m. Eastern Time (“ET”) on May 1, 2026 and ends at 11:59:59 p.m. ET on June 23, 2026 (the “Sweepstakes Period”). The Sweepstakes Period will consist of five (5) entry periods (each an “Entry Period”) as described in the chart below. Each Entry Period will begin at 12:00:00 a.m. ET and end at 11:59:59 p.m. ET.

2. **Eligibility:** The Sweepstakes is open only to legal residents of Ontario, Canada who are 18 years of age or older as of the last day of the month prior to date of entry. - a.) **Enter Online:** You may enter the Sweepstakes by visiting pgbrandsaver.ca/signup/tampaxsweepstakes to sign up or log in to your P&G brandSAVER account and complete the on-screen registration form to receive one (1) entry into the applicable Entry Period random drawing and any subsequent random drawing(s). There is no cost to register for P&G brandSAVER. Limit one (1) online entry per person/email address via the online method of entry.
- b.) **Enter by Email:** You may earn a Sweepstakes entry without signing up for P&G brandSAVER by sending an email to tampax@dja.com. The email must include your first and last name, mailing address and month and year of birth to receive one (1) entry into the applicable Entry Period random drawing and any subsequent random drawing(s).

All entries must be received prior to 11:59:59 p.m. ET on the end date of the applicable Entry Period to be eligible for that Entry Period’s drawing. Non-winning entries will roll over to subsequent Entry Period drawing(s). 6. **Winner Notification/Prize Redemption:** Potential winners will be notified by email on or about the drawing dates listed above.
