Wilmar does not source from Gilford Ltd but their parent company Rimbunan Hijau is associated with suppliers in Malaysia. A meeting was held on 7 September 2018 to further discuss the issues. On 20 September 2018, Gilford Ltd has subsequently provided a written commitment in adhering to the NDPE policy and committed to moratorium of land clearing prior to all necessary assessments, including the HCV and HCS assessment. This led to the Roundtable on Sustainable Palm Oil ("RSPO") initiating a legal and operational audit of FGV's recruitment and employment processes in 2018, and ultimately two petitions being filed in 2019 to U.S. Customs and Border Protection ("CBP") requesting the exclusion of FGV palm oil and palm oil products produced with forced and child labor pursuant to 19 U.S.C. 1307. BLC is committed to promoting healthy, safe, and legal working conditions. This includes prohibiting forced labor in any form; specifically, prison labor, indentured labor and bonded labor. BLC hires employees who meet local minimum-age requirements. In addition to meeting Bunge's global standards, BLC operations must comply with all applicable local laws, rules and regulations. Because of BLC's strong stance against forced labor, BLC stopped sourcing palm oil and palm oil products from FGV, and for our indirect supply BLC ensured that our suppliers are likewise following this prohibition. BLC will continue to engage with FGV over the allegations and monitor progress for remediation. Only once FGV can demonstrate that the allegations are properly addressed and the US CBP has lifted the WRO, BLC will reassess its position on FGV.	CLOSED CASE

The implementation of remediation will be verified by ELEVATE. In parallel, BLC also engaged FGV directly to seek progress update on the enhanced sustainability governance and ethical & fee free recruitment practices implemented, including measures taken to identify critical control points throughout the recruitment process. On remediation of worker paid fees, FGV is committed to remediate such fees to both, current and former workers, that did not benefit from FGV's recent Fee Free Recruitment practice.
