



Opus Energy Deemed and Out of Contract Gas Rates

Deemed: If you recently moved into a property that we supply with gas, but haven't agreed a contract with us, we won't leave you without power. You'll be on what's known as a 'Deemed Contract'^. We'll charge you our Deemed rates until you agree a new contract with us or switch to a new supplier. You can find the link to Deemed terms and conditions on the webpage. Please note that these rates are not fixed so may change at any time, so check our website for more details.

Out of Contract: Out of Contract rates apply to the gas we supply to Opus Corporate customers when a fixed period ends and a new contract has not been entered into either with us or a new supplier. We'll charge you these rates until you switch to another supplier. Please note that these rates are not fixed, and they may change at any time, so check our website for more details.

Gas rates are calculated using the amount of gas a site uses over a period of 12 months; this is called Annual Quantity banding (AQ). If you know which AQ banding your property fits into, you can use the table below to look up the rates. If you do not know, please contact us and we will be able to tell you your banding and its associated rate.

From March 2023, we've made the decision to begin to move away from supplying gas. To tackle the climate crisis, the world needs secure, renewable energy – and to remove carbon from the atmosphere.

To support this aim to reduce carbon emissions, we'll be focusing on supplying renewable electricity. If you have a gas contract, you'll need to find an alternative supplier if you want to secure the most competitive price for your supply in future.

If you also have an electricity contract with us, you don't have to worry, and you don't need to do anything. We'll continue to supply your business with electricity as usual, and will continue to offer long-term renewable electricity contracts.

Qualifying Financially Disadvantaged Customers (QFDC)

Qualifying Financially Disadvantaged Customers (QFDC) discount is an additional government support that is included in our Deemed and Out of Contract rates.

Our Deemed and Out of Contract rates are calculated taking into account this additional government support. This QFDC discount is included in our published rates and is in addition to the Energy Bill Relief Scheme discount (which will be displayed on your bill separately).
