

## Opus Energy Deemed electricity rates

If you recently moved into a property that we supply with electricity, but haven't agreed a contract with us, we won't leave you without power. You'll be on what's known as a 'Deemed Contract'. ### Qualifying Financially Disadvantaged Customers (QFDC)

Qualifying Financially Disadvantaged Customers (QFDC) discount is an additional government support that is included in our Deemed and Out of Contract rates.

Our Deemed and Out of Contract rates are calculated taking into account this additional government support. This QFDC discount is included in our published rates and is in addition to the Energy Bill Relief Scheme discount (which will be displayed on your bill separately).
