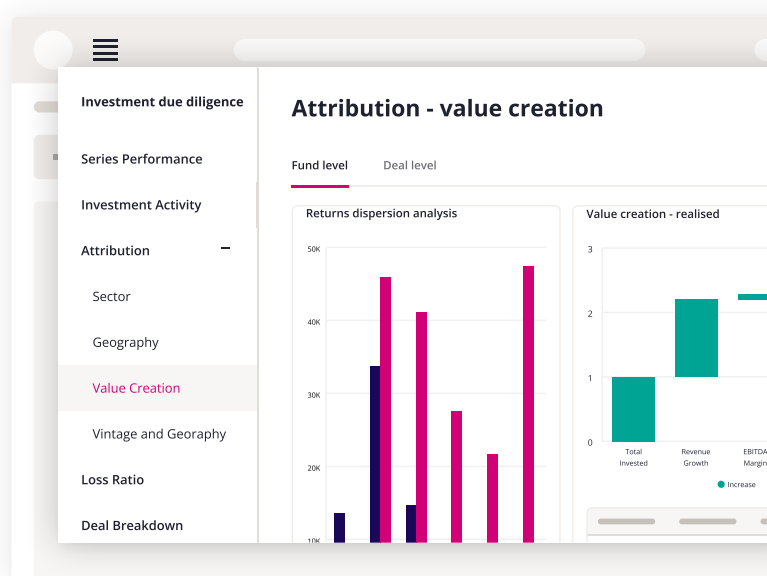
Assess fund manager consistency and performance replicability

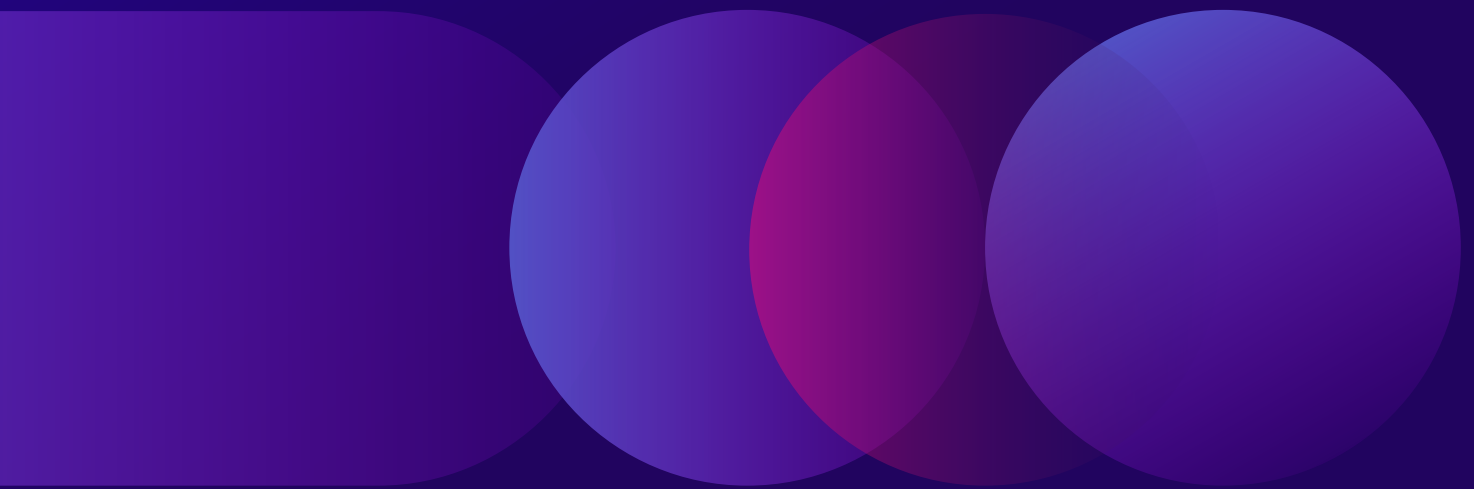

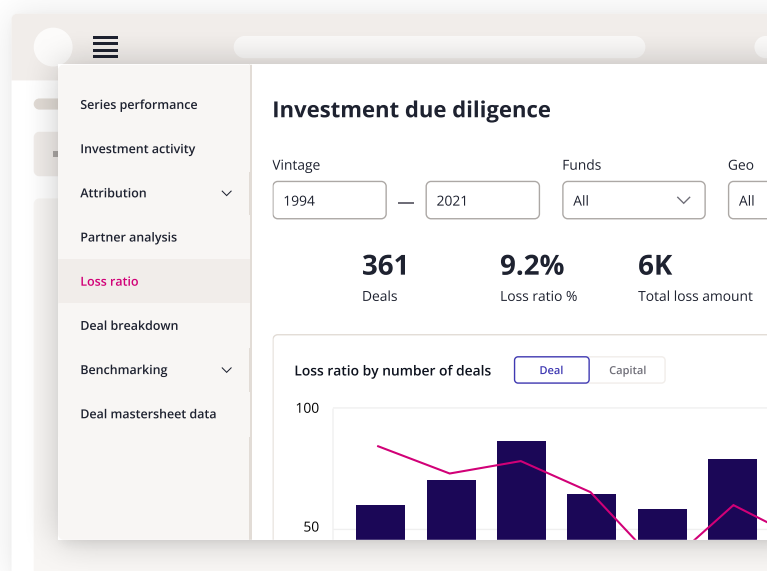

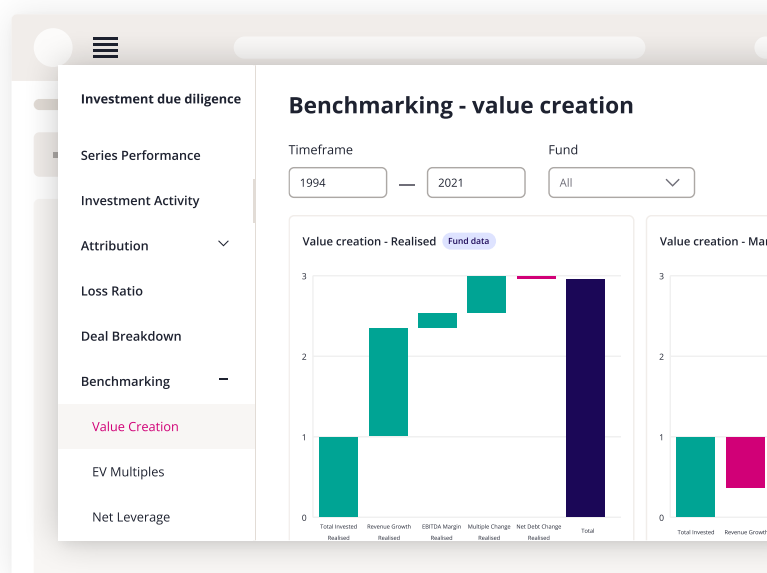
