

## Full terms and conditions

- 1 Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions. Nothing in these conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).
- 2 Entry is open only to Australian residents aged 18 years or older. Directors, management and employees of the Promoter and associated companies and agencies as well as the immediate families (spouse, children, parents, grandparents, grandchildren, and siblings, as well as step, adoptive, and de facto relations) of each of these people are not eligible to enter.
- 3 The promotion begins at **12.01 am AEST, 4<sup>th</sup> of June, 2026** and closes **11.59pm AEST, 1<sup>st</sup> of July, 2026 (Promotion Period)**.

- 6 The Promoter accepts no responsibility for any late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence, whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise
- 7 The Promoter is not liable for any consequences of user error including (without limitation) costs incurred.

- 9 The draw will be conducted at 9am AEST on 15<sup>th</sup> of July, 2026 at Level 10, 77 Castlereagh Street, Sydney. The first 20 valid entries randomly drawn will each win a prize.
