MOTORCYCLE DEALER INVOICE FINANCING/-I
READY.SET.GROW

Campaign Period

- 1) This **MOTORCYCLE DEALER INVOICE FINANCING/-I READY.SET.GROW** (“**Campaign**”) is organised by Modalku Ventures Sdn Bhd (“**Funding Societies**”) and shall run from 1 June 2025 to 31 December 2025 (“**Campaign Period**”). However, new motorcycle dealers (hereinafter referred to as “**Eligible Customer**”) must sign financing agreement between 1 June 2025 and 31 August 2025 (both dates inclusive, the “**Registration Period**”). Eligible Customers who successfully sign a new financing agreement during the Registration Period will have until 31 December 2025 to fulfil the other relevant campaign conditions.
- 2) Where applicable, an additional One (1) month period from the expiry of the Campaign Period, may be allocated for purposes of tracking the financing approval and disbursement (“**Tracking Period**”), subject to any extension of Campaign Period and/or changes to the requirements of Campaign.

Eligibility Criteria

- 3) This Campaign is open to new motorcycle dealers and is applicable exclusively to the Motorcycle Dealer Invoice Financing/-i product offered by Funding Societies in Malaysia.
- 4) The following eligibility criteria must be duly fulfilled to be qualified for the participation of the Campaign:
 - *New financing agreement must be signed between the Registration Period;*
 - *Drawdown request for disbursement must be made by or no later than 31 December 2025.*
 - *Eligible Customer must utilize at least 120% of their approved credit limit during the Campaign Period (“Utilisation Threshold”).*
 - *Full and timely repayment of all amounts due under all utilisations made within the Utilisation Threshold. Any payment that is overdue by more than 6 days is NOT allowed.*

For the avoidance of doubt, any payment delay, delinquency, or default exceeding 6 days in any one (1) utilisation under the facility shall automatically disqualify the Eligible Customer from being entitled to the rebate.

- 5) Employees of Funding Societies, its appointed agencies or vendors (including affiliated and related companies, as well as their immediate family members) who are directly involved in this Campaign are not eligible to participate in this Campaign.
- 6) Any person who has committed, or is suspected of committing, any misconduct, fraud, or wrongful acts in relation to their account(s), or any facility or service provided by Funding Societies, is not eligible to participate in this Campaign.

Campaign Reward

- 7) Eligible Customer who meet the eligibility criteria will be entitled to a 100% rebate on the utilization fee.
- 8) The rebate will be credited to you after the conclusion of the Campaign Period, subject to verification that all eligibility criteria have been met. Customers who are confirmed to be eligible will receive the rebate by the last working day of the subsequent calendar month.

General Terms and Conditions

- 9) By participating in this Campaign, the Eligible Customers are deemed to have read, understood and agreed to be bound by all the Terms and Conditions ('Terms and Conditions') stated herein.
- 10) These terms and conditions and the Funding Societies' decision on all matters relating to this Campaign shall be final and binding on all the Eligible Participants and no correspondence and/or appeal in respect thereof shall be entertained.
- 11) By participating in this Campaign, Eligible Participants consent to:
 - a) Collect, record, hold, store, use, and disclose their personal information for purposes related to the Campaign;
 - b) Disclose their personal information (including names, addresses, telephone numbers) to Funding Societies' related and/or associate companies, business partners, strategic alliances, and other third parties as deemed necessary by Funding Societies for the Campaign, and
 - c) Allow their photos or video clips to be used for current or future advertising and/or publicity related to the Campaign without any claim for payment or compensation.
- 12) Upon the expiry of the Campaign Period, the Campaign will be deemed terminated, and this offer will immediately lapse without notice.
- 13) The Prizes or Reward are not transferable to any third party, non-negotiable and nonexchangeable for cash, kind, in part or in full and/or other redemption item(s).
- 14) Funding Societies reserve the right to substitute or change the Prizes or Reward with a similar or lower value at its absolute discretion.
- 15) The Prize or Reward may be withdrawn or cancelled by Funding Societies at its sole discretion if any purchase or transaction made by Eligible Participants under this Campaign is refunded, voided, cancelled, or deemed fraudulent.
- 16) Funding Societies reserves the right to disqualify Eligible Participants from receiving the Prize or Reward if they fail to comply with these Terms and Conditions, or engage in fraudulent or wrongful acts related to the products.
- 17) Funding Societies shall not be liable for any claims, losses, damages, or costs incurred or suffered by any participants as a result of your participation in this Campaign.
- 18) Funding Societies shall not be responsible nor shall accept any liabilities of whatsoever nature howsoever arising or suffered by the Eligible Participants resulting directly or indirectly from this Campaign. For the avoidance of doubt, any cancellation, termination, suspension or extension of this Campaign or disqualification of the Eligible Participants or forfeiture of the Campaign shall not entitle the Eligible Customers to any claim or compensation against the Organisers or for any and all losses or damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of cancellation, termination, suspension, extension, disqualification or forfeiture.
- 19) The Terms and Conditions may be amended from time to time and shall prevail over any provisions or representations contained in any other or advertising materials. In the event of inconsistency, the latest version of these Terms and Conditions shall supersede any previous Terms and Conditions.

20) These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
