The \$50 rebate is valid on all RDT and RXT automatic transfer switches; the \$100 rebate is valid on 10RESV(L), 12RES, 12RESV(L), 14RESA(L), and 14RCA(L); the \$200 rebate is valid on 20RESC(L), 20RCA(L), and 26RCA(L); the \$300 rebate is valid on 24RCL(A), 30RCL(A), 38RCLB/C, 48RCLB/C, 60RCLB/C, KG80R, KG100R, KG125R, 150ERESC KOHLER generators.
