Celonis training and individual certification is available at no charge at http://www.celonis.com/training.

Entrants are limited to one entry per certification track during the Entry Period. You may make one entry per certification track, up to a maximum of nine entries (one each for the Executive, Business User, Analyst, Data Engineer, Business Value Architect, App Creator, Solution Professional, Implementation Professional, Sales Professional, EMS Kickstarter, Snap Training, Train the Trainer or one of the three Academic Alliance tracks) during the Entry Period. Entrants may only win once for each certification track entry.
