

Celonis World Tour 2023 Attendee Terms and Conditions

THE FOLLOWING ATTENDEE TERMS AND CONDITIONS ("TERMS") GOVERN YOUR REGISTRATION AND PARTICIPATION IN THE CELONIS EVENT FOR WHICH YOU ARE REGISTERING (THE "EVENT"). BY CLICKING THE "I ACCEPT" OR "SUBMIT" BUTTON DURING THE REGISTRATION PROCESS, OR BY ATTENDING OR PARTICIPATING IN THE EVENT IN ANY CAPACITY, YOU ACCEPT AND AGREE TO BE BOUND BY THESE TERMS AND REPRESENT THAT YOU HAVE READ AND UNDERSTAND ALL THE PROVISIONS HEREIN. YOU MUST NOT SELECT THE "I ACCEPT" OR "SUBMIT" BUTTON, OR ATTEND OR PARTICIPATE IN THE EVENT IN ANY CAPACITY IF YOU DO NOT AGREE TO THESE TERMS. AS USED HEREIN, "YOU" AND "YOUR" MEANS THE INDIVIDUAL REGISTERING FOR OR PARTICIPATING IN THE EVENT, AND THE COMPANY OR OTHER LEGAL ENTITY BY WHICH YOU ARE EMPLOYED OR FOR WHICH YOU ARE ACCEPTING THESE TERMS. THE "EFFECTIVE DATE" OF THESE TERMS SHALL BE THE DATE THAT YOU CLICK "I ACCEPT" OR "SUBMIT." THESE TERMS ARE BETWEEN YOU AND CELONIS DEUTSCHLAND GMBH AND ITS AFFILIATES, SUBSIDIARIES, AGENTS AND SERVICE PROVIDERS (COLLECTIVELY, "CELONIS").

By submitting an event registration, purchasing event tickets, or otherwise expressly agreeing to these Attendee Terms and Conditions ("Terms"), YouYou are entering into a legally binding contract with Celonis Deutschland GmbH, Theresienstrasse 6, 80333 Munich, Germany ("**Us**") pursuant to these Event Terms and Conditions (the "**Terms**"). You confirm that You are an adult of 18 years or older, that You are legally entitled to represent the legal entity for which You submit the registration for the Celonis World Tour 2023 ("**Event**") and that You have read, understood and agree to these Terms as well as to the Celonis Privacy Policy (https://www.celonis.com/privacy-policy/).

Registration Policy:

Each ticket for the Event represents a single entry per person. You may transfer the pass to another colleague within the same company no later than one week before the Event by writing an email to <u>events@celonis.com</u> specifying the full name and the job title of the new attendee, or by using the self-edit function provided by Celonis' event registration and management platform (You can access this function through the link in Your registration confirmation email). Please note that the registration form data (including the session registration data) will be transferred from the previous attendee to the new attendee.

Ticket Availability:

The registration for the Event may close earlier than posted deadlines as Event registration is subject to availability.

Cancellations:

You may request to have Your registration canceled by submitting a written request. Cancellation requests must be emailed to <u>events@celonis.com</u> and specify the ticket number and the full name of the ticket owner. Please consider that instead of canceling, You can transfer the ticket to someone else as described under the "Registration Policy" section, above.

Event Program:

The Event agenda published on the registration website is provided for informational purposes only and is subject to change without notice. Celonis does not guarantee the attendance of any exhibitor or speaker, or that any scheduled event will take place, particularly in the event of any natural or participation public disaster. insufficient or sponsorship, government regulation or shutdown, necessary venue construction, labor controversy, civil disturbance, acts or threats of terrorism, armed conflict or similar reasons beyond its reasonable control. Celonis will not be liable and no reimbursement will be made in the event of a cancellation or modification of times, dates, or sessions.



Session Registration:

After Your registration for the Event, You can view the event agenda on our website. The session seating is first-come, first-serve and some sessions may fill up due to popular demand.

Event Management:

You may be required to present identification and pick up a badge at the Event check-in area before entering the Event. If badges are required for admittance, they must be worn and visible at all times while You are at the Event and during any activity associated with the Event. Badges may not be shared or exchanged with any person.

Security and Property:

Celonis reserves the right to take any security measures that it deems necessary, and without prior notice, to increase the safety of attendees and exhibitors. You should not leave bags or other property unattended. Unattended property may be removed from the Event venue, and Celonis will not be responsible for any loss or damage of any kind relating to such removal. Event management staff may conduct security checks at any time during the Event, including, but not limited to, inspections or scans of any attendee's or exhibitor's person and/or their clothing, bags, containers and other items. Firearms, explosives and other weapons and hazardous materials that could be used to cause injury to another attendee are strictly prohibited at the Event venue and related activities. Celonis retains sole discretion to deny entry to the Event to anyone for any reason.

Health and Safety Protocols:

Celonis will comply with all World Health Organization or Center for Disease Control and Prevention guidelines, as appropriate, in addition to national and local guidelines to ensure a safe, controlled environment for everyone. As an attendee, You expressly agree to fully comply with applicable COVID-19 health and safety measures and protocols for attendance at the Event. Attendees are expected to respect the protocols that have been put in place for the Event and act responsibly.

Minimum Age:

You must be at least 21 years of age to attend the Event except as agreed in writing by Celonis.

Event Conduct:

Celonis reserves the right to refuse admission to, or to eject, any person whose conduct is disorderly, disruptive, harassing, vulgar, obscene, indecent, defamatory, hateful or otherwise offensive (including conduct consisting of disparaging statements or opinions regarding race, gender or ethnic background) or who fails to follow any of Celonis' other rules or directions, as determined by Celonis in its sole discretion.

Personal Information and Recordings:

Celonis will handle Your personal information in relation to the Event in accordance with <u>Celonis'</u> <u>Privacy Policy.</u>

Celonis may use Your registration information to send You emails with updates and surveys regarding the Event as well as for other marketing purposes.

When we ask third parties to host, sponsor or present at events, including webinars and trainings, we may forward your contact data to the respective third party who may use it to provide access to the event or to contact you for related marketing purposes.

In addition, if You attend a live Event, You will be provided with a badge. Badges may contain tags to record Your participation in break-out sessions and other activities during the Event. By permitting a presenter, partner or exhibitor to scan Your badge during the Event, You authorize Celonis to share Your registration information with that particular presenter, or exhibitor and agree to partner receive communications from such presenter, partner or exhibitor. You acknowledge that the Event is a public event and that Celonis and its agents will photograph and record the Event and activities related to the Event in visual and audio media. By attending the event, You agree that (1) Your name, company name, voice, picture, photograph, other reproductions of Your likeness (collectively, Your "Image") may appear in photos and recordings of the Event; and (2) Celonis is granted the right to record, transcribe, modify, perform, reproduce, display, distribute and transmit in any form Your Image in connection with any advertising or promotional content and materials, and for any other lawful purpose, including by posting on public websites, without any compensation to You. However, Celonis is not obligated to make any use of Your Image, or exercise any of the rights granted to it.

Assumption of Risk and Release of Liability:

You understand that participation in the Event is voluntary and carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. You hereby agree to indemnify, release and hold harmless Celonis, its officers, directors, employees, vendors, partners, agents and contractors (collectively, "Releasees") from any and all alleged and/or actual liability, claims, actions, lawsuits, damages and losses of any kind, including attorneys



fees, which arise out of or result from Your attendance at and participation in the Event and ancillary activities, including but not limited to property damage and personal injuries, illness, death or other physical loss, whether or not foreseeable.

The limitations and exclusions in this section shall not, with respect to any Releasee, apply to willful misconduct, fraud or fraudulent misrepresentation, gross negligence and personal injury or death caused by negligence, attributable to such Release.

Final Provisions:

These Terms and all claims arising hereunder will be governed by and construed in accordance with the laws of the State of New York if the Event is scheduled to occur within the USA, Canada or Mexico, or the laws of England and Wales if the Event is scheduled to occur in any other country, excluding the conflict of laws principles of the forum country. The United Nations Convention on the International Sale of Goods (CISG) shall not apply. Any judicial action with respect to the Event or these Terms shall be filed exclusively in the federal or state courts located in the County of New York, New York if the Event is scheduled to occur in the USA, Canada or Mexico, or in London, England if the Event is scheduled to occur in any other country. You hereby irrevocably waive any and all claims and defenses You might otherwise have in any action or proceeding in any of such courts based upon any alleged lack of personal jurisdiction, improper venue, forum non conveniens or any similar claim or defense.

If any provision of these Terms is for any reason found to be unenforceable, the remainder of these Terms will continue in full force and effect to the fullest extent permitted by law.

These Terms and their incorporated documents, together with Your registration for the Event, constitute the complete and exclusive understanding and agreement of the parties and supersede all prior understandings and agreements, whether written or oral, with respect to the subject matter hereof. Any purchase order, purchasing terms, general terms of business or other document issued by You is for administrative convenience only and shall not be binding on Celonis.

Any amendments or additions to these Terms must be made in writing and executed by duly authorized representatives of both parties. Notwithstanding the foregoing, Celonis reserves the right to change the policies set forth in these Terms without prior notice.

Should parts of these Terms be or become invalid,

this shall not affect the validity of the remaining provisions of these Terms, which shall remain unaffected. The invalid provision shall be replaced by the parties with such term which comes as close as possible, in a legally permitted manner, to the commercial terms intended by the invalid provision.
