This website, <https://global.lockton.com/>, (“Website”) uses cookies to distinguish you from other users of our Website. This helps us to provide you with a good experience when you browse our Website and also allows us to improve our Website.

## 1. Your Agreement/Cookie Options

- 1.1 By continuing to browse our Website, you are agreeing to the placement of cookies on your computer in accordance with the terms of this Cookies Notice (“Notice”). If you do not desire to accept cookies from this Website, please either disable cookies or refrain from using this Website. You may change your cookie settings at any time. The last section of this Notice addresses how to block or decline cookies. This Notice applies to this Website only and does not apply to any websites to which this Website may link.

## 2. What are Cookies?

- 2.1 Cookies are files that contain small amounts of data. They are placed on your computer or other device by the websites you visit. Different kinds of cookies do different things—ranging from making a website work to making it easier to use to enabling website owners to understand more about their visitors. Some cookies are stored in your browser and some on the hard drive of your computer. Session Cookies are automatically erased when you close your browser; Persistent Cookies, unless deleted, remain on your computer or other device until a set expiration date. Cookies contain information that is transferred to your computer’s hard drive.

## 3. Our Use of Cookies

- 3.1 We use the following categories of cookies:

- **Strictly Necessary Cookies:** These are cookies that are required for the operation of our Website. They include, for example, cookies that enable you to log into secure areas of our Website.
- **Analytical/Performance Cookies:** These are cookies that allow us to recognise and count the number of visitors and to see how visitors move around our Website when they are using it. This helps us to improve the way our Website works, for example, by ensuring that users are finding what they are looking for easily.
- **Functionality Cookies:** These are cookies that are used to recognise you when you return to our Website. This enables us to personalise our content for you and remember your preferences, for example your choice of language or region.
