

COMIC RELIEF'S STATEMENT ON MODERN SLAVERY AND HUMAN TRAFFICKING

INTRODUCTION

The Modern Slavery Act 2015 requires certain large UK organisations to publish an annual statement on the steps they are taking to prevent modern slavery and human trafficking in their operations and supply chains.

Comic Relief's annual turnover is below the Act's reporting threshold. Although we are not legally obliged to make a statement, we do so voluntarily to demonstrate our commitment to ethical trading principles and to ensure our operations and supply chains are free from modern slavery and human trafficking.

ABOUT US

Comic Relief is a UK charity which uses the power of humour and popular culture to engage people to help others and raises money to support organisations working towards a just world, free from poverty. We raise funds in a number of ways, including through our annual Red Nose Day, Sport Relief and winter campaigns; fundraising; events; corporate partnerships; and sales of merchandise.

STRUCTURE

The Comic Relief group comprises three entities – Charity Projects, Comic Relief Limited and Brand Relief Limited. Charity Projects is the parent entity, a registered company limited by guarantee in England & Wales, and a registered charity with the Charity Commission in England & Wales as well as the Office of the Scottish Charity Regulator. Comic Relief Limited and Brand Relief Limited are private companies limited by shares and Comic Relief Limited is a wholly owned trading subsidiary.

OUR OPERATIONS

In our own operations:

- We are registered and operate as a Real Living Wage employer. This is a UK wage rate calculated on the real cost of living, which is voluntarily paid by organisations such as Comic Relief and endeavours to enable employees to meet actual living costs in the UK.
- Over the past year, we have rolled out a number of policies and processes to further our continued commitment to high ethical standards, including an Ethical Framework, which sets out the guiding principles in order to help us:
 - influence and shape our current policies, procedures and relationships including our decision-making processes;
 - ensure consistency and alignment across all aspects of our organisation; and
 - establish a set of core principles which support our goal to drive positive change through the power of entertainment.
- We provide training to our staff, and where appropriate, our contractors, on our key policies.
- We have safeguarding policies and processes in place to prevent child labour and safeguard our employees, beneficiaries, suppliers and partners. This includes safeguarding provisions in our agreements with third parties.
- We have clear reporting concerns and whistleblowing processes for our staff, contractors and any third parties.
- To help fight against corruption, we have a detailed Anti-bribery and Corruption Policy in place.

WORKING WITH THIRD PARTIES

Our Ethical Sourcing Policy demonstrates our commitment to acting ethically and with integrity in our business relationships, and our commitment to act through effective systems and controls to ensure slavery and human trafficking is not taking place in our supply chain. We recognise that our highest point of risk in our merchandise sourcing is in the production of branded merchandise.

Corporate partners – the majority of our branded merchandise is manufactured by our corporate partners, who share our commitment to ending and eliminating slavery and human trafficking in their supply chains. These partners regularly audit their processes, practices, and standards, including those parts of the supply chain involved in the manufacture of our branded merchandise to ensure they comply with our Ethical Sourcing Policy, and we review such audits with our partners to agree corrective actions where necessary.

Non-partners – when we engage suppliers for branded merchandise directly, we undertake due diligence in advance following our Ethical Sourcing Guide. We also strive to ensure they have a contractual commitment to comply with our Ethical Sourcing Policy and to work in accordance with the Act. These suppliers are required to demonstrate regular audits of their supply chain involved in the manufacture of branded merchandise, and we review such audits with the supplier to agree corrective actions where necessary.

Other suppliers – in our agreements for other goods and services, where possible, we contractually require our suppliers to comply with our Ethical Sourcing Policy and with the law, which includes the Act. Where we are conducting a procurement tender process, one of the criteria we score against is evidence of alignment with Comic Relief's values, especially the Ethical Sourcing Policy.

Due diligence – to identify and monitor the risk of slavery and human trafficking in our supply chain, our Ethical Sourcing Guide sets out a risk-based due diligence process which we apply to new suppliers.

FURTHER STEPS

We will continue to review and improve our policies and processes to ensure they continue to meet the commitments set out in this statement.

We are committed to regularly reviewing and updating our Ethical Sourcing Policy and Ethical Sourcing Guide, to ensure these reflect best practice. We expect to review both the Policy and Guide by the end of October 2026.

We have also implemented a Partnerships Screening Policy, which requires that potential partners, trusts, foundations, institution donors and fundraisers are risk assessed against a number of factors, including compliance with Comic Relief's ethical sourcing objectives. This Policy will also be reviewed and updated by the end of October 2026.

We are continuing our work on equitable story telling, to ensure our storytelling practices are equitable, safeguard our contributors and are representative of the communities we serve.

Our financial year end is 31 July 2025.
