

BUCKET COLLECTION GUIDANCE



Thank you for planning a bucket collection for Comic Relief. To make sure your fundraising is safe, legal and considerate, please follow the guidelines below.

First of all, it's really important that you get the right permission before you start collecting.

FRIDAY 17 MARCH

Street Collections

If you're holding a collection on the street, you'll need to obtain a licence, either from your local authority, or, if you're in Greater London, the Metropolitan Police.

Collections on a Private Property

If your collection is open to the public but being held on private property (e.g. within a shopping centre or rail station) you must obtain permission from the landowner or manager.

House to House Collections

We do not permit house to house collections as we're not authorised to fundraise in this way.

Static Collections

You don't need a licence to place a static collection box/bucket in a shop or business, just permission from the business owner.

DO'S & DON'TS

Do

- Use a Red Nose Day bucket label and ensure that it's clearly visible.
- Ensure that your bucket is secure, with either a lid or a seal so people can't see the cash.
- Write your name and contact details in the space provided on the bucket label.
- Wash your hands or use sanitiser before and after touching cash.
- If you need to pay in at a bank or go to the post office, follow any Covid-19 protocols they may have in place.
- If you're ever challenged while handling cash, hand over the money without resistance and immediately report the incident to the police and then to Comic Relief.
- Bank cash as soon as possible after collection.
- Consider other means of payment including using JustGiving page QR Codes.

Don't

- Cause, or be likely to cause, danger, obstruction, inconvenience or annoyance to any person while carrying out your collection.
- Shake the bucket while carrying out your collection.
- Leave cash unattended.
