# Crédit Agricole Pyrénées Gascogne, Essor and Teréga inaugurate an HQE building in Artix: a strong commitment to a sustainable future

Investor Crédit Agricole Pyrénées Gascogne, developer-builder Groupe Essor and Teréga, the historic operator of gas transport and storage infrastructure in the south-west of France, are today inaugurating the new HQE (High Environmental Quality) building for Teréga's operating teams in Artix (64), where Teréga is the tenant.

# An eco-designed building for the future

Designed to meet the growing needs of Teréga's teams, this project embodies an exemplary approach to sustainable construction and positive territorial impact. Covering an area of 650 m², the new building has been designed to combine energy efficiency with employee well-being. It incorporates innovative solutions to reduce its carbon footprint and optimise the use of natural resources:

- **Bio-sourced materials:** framework, cladding and insulation in wood from French species
- **Energy autonomy:** self-consumption photovoltaic panels
- **Responsible water management:** recovery of rainwater to supply sanitary facilities and the vehicle washing area
- **Thermal and energy performance:** excellent airtightness (well below the regulatory threshold)
- **Optimised natural lighting:** large openings and skylights to reduce electricity consumption

## A local development project

The construction of this HQE building, which took 13 months, was a driving force for the local economy. **98% of the companies that worked on the project were located less than 40 km from the site**. Three companies from Artix were directly involved in the project, representing **44% of the total cost of the work** and reinforcing the local roots of the project.

## An exemplary site in terms of environmental management

The entire construction process was carried out responsibly:

- 91.3% of construction site waste was recycled
- **Rigorous monitoring of** water and electricity consumption
- No nuisance reported during the works







## Local collaboration at the heart of the project

This project symbolises the synergy between three players committed to the development of the region:

- **Crédit Agricole Pyrénées Gascogne**, the building's owner and investor, which has been supporting local economic and environmental initiatives for many years.
- The **Essor Group**, experts in sustainable property solutions, who were able to meet Teréga's operational and sustainable development requirements.
- Teréga, the building's user, whose teams moved in on 11 December 2024.

This project is fully in line with the CSR strategy of these three local players, who are continuing to strengthen their commitment to more sustainable and responsible infrastructures.

Established in South-West France, at the crossroads between major European gas flows, Teréga has exercised exceptional expertise for 80 years in the development of gas transport and storage infrastructures. Today, it continues to develop innovative solutions to overcome the major energy challenges facing France and Europe. A true accelerator of the energy transition, Teréga operates over 5,000 km of pipelines and 2 underground storage reservoirs representing 15.6% of the French gas transport network and 26.9% of national storage capacity. In 2023, the company generated revenues of €494 million (excluding balancing and congestion) and had more than 646 employees.
