## **Agnès Butterlin appointed as Director of Finance and Purchasing at Teréga**



From 1 June 2020, **Agnès Butterlin** will be appointed **Director of Finance and Purchasing** at Teréga SA and therefore becomes a **member of the Executive Committee**. She is replacing Roberto Zingoni in this position as he returns to SNAM.

Agnès brings with her more than 25 years of experience in different areas of finance and more than 15 years in the energy sector.

Her main task will be to manage Teréga's budget, to ensure its overall financial needs in the short and medium-long term, and to implement the company's Business Excellence programme, continuing the work of her predecessor.

Before joining Teréga, Agnès was the Chief Financial Officer from 2014 for the Belgian subsidiary of EDF, Luminus, energy producer and supplier on the Belgian market committed to the energy transition, and greatly contributed to transforming the Finance position in the company. In this regard, she was also a member of the Board of Directors of Newelec, an SME from Liège that was acquired in 2017, and Chairperson of Luminus Solutions, a supplier of B2B energy solutions.

In 2002, she joined the EDF Group, where she worked for more than 15 years, before being promoted to the position of Group International Finance Director in 2011. From 2002 to 2011 she successively held positions as Head of Projects and Acquisitions in the Development branch (2002-2003), Head of Projects and Partnerships for Western Europe (2003-2005), Chief Financial Officer for Central Europe (2005-2010) and finally Chief Financial Officer for the management of residential clients (2011).

Agnès was responsible for a programme for the assignment of assets at Framatome between 1999 and 2001.

She began her career with PricewaterhouseCoopers (1992-1999) as an auditor and later Manager of Transaction Services.

Agnès is a graduate of the Grenoble School of Management and is qualified as a chartered accountant.

Alongside her professional activity, Agnès is a member of the French Institute of Directors (*Institut Français des Administrateurs—IFA*).
