

TERMS AND CONDITIONS FOR WESTFIELD DINE WITH US OFFER 2024

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield **Sydney** Dine with us offer (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 16 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. Gift Card must be redeemed on the date of purchase. Limit of 250 Westfield Gift Cards during the promotion period.
