

TERMS AND CONDITIONS FOR WESTFIELD “Matariki Star Hunt Competition”

Information on how to enter and prizes forms part of these Terms and Conditions. Participation in this “Matariki Star Hunt Competition” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.

WHO CAN PARTICIPATE?

2. Subject to condition 3, this Promotion is only open to New Zealand residents aged 18 years or over.
3. Matariki Star Hunt participants can be younger than 18 years however entry into the prize draw must be made by the entrant’s parent or guardian aged 18 years or over.
4. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in a Participating Centre (as defined in Clause 5 below) or any of the Promoter’s agencies or suppliers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. This Promotion commences at 9.00am on Monday 6 July 2020 and ends at 5.30pm on Sunday 19 July 2020 (“**Promotion Period**”). Entries received after this closing time will not be eligible for entry.

6. The Promotion will be conducted at the following Westfield New Zealand Shopping Centres: Westfield St Lukes, Westfield Riccarton, Westfield Manukau, Westfield Albany (“**Participating Centres**”).
7. To receive an entry in this promotion, eligible individuals must, during the Promotion Period, undertake the following steps:

The provisional winner of the Prize Draw will be notified by phone and email within two (2) business days of the draw. The provisional winner will only be deemed the winner once verified by the Promoter. The Winner must claim their prize by responding to contact attempts before 5.00pm Thursday 24 July 2020.

PRIZES
